"The Government's reform agenda – where are we now?"

THE TALK

The talk will provide an overview of recent and proposed future developments in the health and safety landscape, including the ACoPs and what they really mean in principle and practice.

Richard will also provide a brief overview of how IOSH public affairs work, outlining the key role of public affairs in changing policy and perception about health and safety and summarise some key changes, including;

- 'Health and safety made simple'
- 'Managing for health and safety' (HSG65 refreshed)
- Work at Height and Portable Appliance Testing – debunking myths
- RIDDOR changes
- First Aid changes
- Approved Codes of Practices progress so far
- Brief update on some future changes Deregulation Bill; CDM; and Mining law consolidation

The talk will be followed by syndicate exercises to explore what delegates feel the top 3 health and safety challenges are and why; and specifically, how these should be tackled i.e. what action Government, health and safety professionals and employers should take.

As the IOSH Head of Policy and Public Affairs, Richard leads on the development of the Institution's policies and positions and public affairs strategy, including
