THE SPEAKER

Gary is a long standing and well respected HSE Inspector, based at the Wrexham office, and is known for his wealth of understanding of health and safety law and practical approaches to workplace precautions.

THE TALK

Since 2005 specific legislation has been in place covering working at heights; but what does it mean and does it really ban the use of ladders?

Gary's Talk will offer an insight into HSE thinking on working at heights and deal with practical aspects of how employers can continue to do their work whilst staying the right side of the law.

His Talk will consider such things as the use of:

- Crawl Boards
- Ladders
- Access Platforms

Also, Gary will use case studies and examples from industry; examples that should not only squash the 'myths' but also inform on recent initiatives and thinking.

WORKING AT HEIGHTS

Falls from height remain the most common cause of workplace fatality, with between half and two thirds occurring in the construction industry.

During 2007 / 08 there was 229 workplace fatalities, with 58 caused by falls from height, an increase of 12% on the 2006 / 07. In addition, falls account for 48% of all fatal injuries to the self-employed. A majority of major injuries amongst employees are also as a result of falls, with 3,235 (12%) in 2007 / 08.
