‘ASBESTOS ROADSHOW’

THE EVENT

Do you know?

- Asbestos still kills around 5000 workers each year, this is more than the number of people killed on the road.
- Around 20 tradesman die each week as a result of past exposure
- Asbestos is not just a problem of the past. It can be present today in any building built or refurbished before the year 2000.

The duty to manage asbestos is directed at those who manage non-domestic premises: the people with responsibility for protecting others who work in such premises, or use them in other ways, from the risks to ill health that exposure to asbestos causes.

If Asbestos containing materials need to be sealed, encapsulated or removed, remember you will need to employ a licensed contractor if the materials are high risk (eg pipe insulation asbestos insulating panels, etc.).

This “road show” / practical event aims to explain, demonstrate a typical licensed asbestos remediation site set-up, provide hands on experience of the working enclosure and what this look like in practice.

So come along, dispel the myths and check out:

- What it’s like inside an actual asbestos enclosure
- How to construct a compliant asbestos enclosure

Refreshments will be provided from 2.00pm.
Talk starts at 2.15pm.

- Methods of removing asbestos containing materials safely
- How air monitoring is undertaken
- 4 stage clearance and “certificates of re-occupation”
- Walk through a decontamination unit
- Track the asbestos from location to disposal.

THE PRESENTERS

The event is being organised by Bangor Universities Estates and Facilities Department in conjunction with: Rhodar Ltd, - HSE licensed asbestos removal contractors, Lucion Environmental - Asbestos Analysts, Surveyors and Consultants.

Representatives from all 3 organisations will be available to discuss legislative site set-up requirements, notification etc., accompany delegates through a tour of the asbestos “enclosure”, decontamination unit and explain associated control procedures, equipment required to meet CAR 2012.

Lucion Environmental will also have a local “laboratory” (microscope and slides) showing how clearance/re-occupation is obtained

CAR PARKING

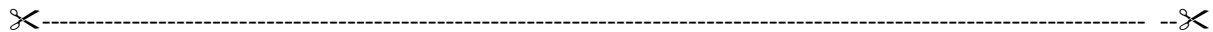

This **PIN number** will only work for these Car Parks and only on the afternoon of the Talk and should not be disclosed / displayed to other people.

Please be aware that parking on campus can be difficult so arrive in plenty of time.

Please ensure you park within designated car parking spaces and display your Permit. The Car Parking Permit is printed at the bottom of this Flyer and must be displayed in the front windscreen. The University operates strict *Parking Regulations* and your vehicle may be towed-away immediately if blocking access or pedestrian routes or otherwise causing a health and safety hazard. Vehicles parked without a valid Permit may be immobilized and a cost is associated with its release.
