'ISO45001: A new International Standard for Health and Safety Management Systems'
David Parr, Head of Audit and Technical, British Safety Council

SPEAKER

David has over 20 years' experience of developing and implementing safety management systems within many sectors including local authority, care services, education, facilities and security.

David's role with the British Safety Council includes responsibility for:

- Development, delivery and maintenance of British Safety Council audit and consultancy products and services
- Occupational Health and Safety Systems development
- Auditing and verifying using the British Safety Council Five Star Management System Audit and OHSAS 18001 Audit Tools
- Occupational health and safety consultancy services, providing technical project management for clients with specific projects
- Quality Assurance management of British Safety Council Audit and consultancy services

David's project management lead technical role has seen him manage specific health and safety consultancy projects for clients within the UK and internationally. Such technical management of projects have included a review of operational procedures at six major plant locations for India's largest supplier of LPG, development of full safety management systems for a major copper mining company in Armenia and occupational health projects for Network Rail within the UK.

In addition to his product management roles, David also acts as the internal Health and Safety Advisor for the British Safety Council and is a member of the organisation's Policy

and Standards Committee who liaise with Regulatory Bodies (such as HSE) in determining BSC Policy direction and Workplace Improvement Campaigns.

David also represents the BSC on the BSI HS1 Committee, which amongst other functions is the UK Forum for liaising with the Development Committee for the new ISO 45001 Standard for International Safety Management Systems. David has also recently been co-opted onto the Working Group to develop BS 45004 the guidance for application of ISO 45001 requirements.
