### "Environmental Management and the Built Environment

#### THE TALK

A case study of Richard's time dealing with Environmental Issues on Major Construction Projects (including Mediacity:UK), and how this has been applied into Environmental Awareness training for Construction and Demolition.

The MediaCityUK project (Phase 1) was a £600M + Project which encompassed 6 major buildings including, commercial, residential, car park, studios and academic, including associated infrastructure (A new Tram stop, landscaped public realm areas, roads and a new bridge over the Manchester Ship Canal) the project at its peak employed over 2000 people per day and had a spend over £1,000,000 per day.

#### The talk will cover topics such as:

- Land remediation (Asbestos, Japanese Knotweed, Heavy oils etc.)
- Environmental Protection on site
- Working near waterways- the ship canal
- Nuisance & Sensitive Receivers (Noise, Dust etc.)
- Waste Management
- Green Building Schemes
- Environmental issues in demolition

#### and delivering effective training:

- Environmental issues and how they are delivered – engaging with the workforce – the usual: "Why is this important? Why should I Care?"
- The importance of plain English and focusing on good practice rather than ever changing regulation in awareness courses.

#### THE SPEAKER

Richard Graduated from Salford University with an Honours Degree in Environmental Management, covering a range of EHS topics from Safety and Environmental Management, to Environmental Health, Management Systems and Environmental Law.

He is a recognised UKATA Asbestos Awareness, and NDTG Demolition Safety Awareness Trainer, and author of an Environmental Awareness Training course for the NDTG (National Demolition Training Group).

He commenced work for Bovis Lend Lease (Now Just "Lend Lease") as an Environmental & Sustainability Manager, where he had responsibility for the Environmental Management on the £600m+ redevelopment of Salford Quays into "MediaCityUK" the new Northern HQ of the BBC, this was in addition to working with suppliers in the region and overseeing work at Liverpool John Lennon Airport and The Trafford Centre.

He now works for the Family Business; Wayne Bagnall Ltd t/a Wayne Bagnall Consulting providing training for environmental issues to the construction and demolition sectors and practical advice on Environmental and Asbestos related topics to a wide range of clients including the Housing associations, private sector manufacturing and the NHS.
